FIRE AND EMERGENCY CALLS FOR SERVICE

Our call volume continues to increase slightly year to year, call types and numbers of each type, remain similarly close to past years.

VOLUNTEERS AND PERSONNEL

Job Announcements have been posted on various sites describing the NRFPD's interest in hiring a full time, paid, Assistant Fire Chief and two, paid, part time, Firefighter/EMT positions. Job Descriptions accompany each announcement. We look forward to interviewing candidates and fulfilling our commitment to the residents of the District to expanding staff and which was approved in the mill levy vote in May of 2018. Our volunteer roster currently stands at 15 in total and includes 6 EMT's and 11 FF. 4 volunteers are currently considered probationary, and we expect they will achieve Active status in the next few months. Keep in mind that our volunteers are truly volunteers as evidenced by a partial list of the duties they perform and time they give:

- o they attend weekly training sessions on Wednesday evenings on their own time
- o they attend certified training classes on their own time
- o they send and receive District communications <u>on their own time</u> . . . and typically on personal cell phones/equipment without reimbursement
- they drive to emergency medical/rescue calls <u>on their own time</u> . . . and often in their personal vehicles
- o they provide wildfire and structure fire services on their own time
- o they respond to vehicle accidents and hazardous incidents on their own time
- o they service and maintain NRFPD equipment on their own time
- o they service and maintain NRFPD buildings on their own time

The next time you see one of our volunteers, remember to thank them for their service!

John Twitchell announced his retirement from the District. John served the District for 12 years; John's forestry and Wildland Fire knowledge was an invaluable asset to the department. He developed training programs that helped train many new volunteers for wildland fire fighting over the years, as well as being a first responder on calls of all types for the department. Thank You for your service John, you will be truly missed by the department.

EQUIPMENT UPDATE

The Board adopted the 2019 Budget in December, 2018; included in the budget was funding to replace our existing staff truck. This truck, a 2002, was acquired used in 2015 and is becoming expensive to operate and undependable. In January, the Board authorized developing staff truck specifications, searching the market for new and used vehicles and evaluate comparable pricing information. After a considerable amount of effort, a vehicle was located, and we are currently finalizing its purchase and the installation of ancillary equipment. The new staff truck is expected to be in service in May.

The balance of the fleet is in good working order. We are presently conducting some repair work to the ladder truck we acquired from Steamboat Springs last summer. It is important that you know that a number of our volunteers and Chief are quite talented "gear heads" as we call them and a great deal of the maintenance of our rolling stock is performed by them as volunteers.

BUDGET AND FINANCIAL

As was mentioned earlier, the Board adopted in December 2018, the 2019 budget for the District. The

budget projects Total Revenues \$566,566 with the major sources of revenues coming from:

> **Property Taxes** \$328,380 (2018 Mil Levy of 9.25)

Property Tax – Bond \$ 94,150 Grants \$ 69,000

The 2019 Budget is balanced. The major expense areas are:

Personnel \$206,077 (includes full year chief wages and benefits, partial year deputy chief

wages and benefits, and partial year, part time paid FF/EMT wages and benefits)

Vehicle Expense \$ 86,600 (includes replacement staff truck) Bond Repayment \$89,450 (repays outstanding bond)

The Residential Assessment Rate (RAR) remained at the current level of 7.2% and therefore the District did not see a significant change in revenues from property taxes due to the Gallagher Amendment. Presently, Colorado Dept of Local Affairs preliminarily reported on 1/15/19 the 2019-2020 RAR will decrease to 6.95%. The final report will be issued 4/15/19.

WILDLAND FIRE PREPAREDNESS

With the amount of snow currently on the ground, it is difficult to think about wildfire season! Perhaps this year, given the levels of snow fall our exposure to wildfires may be minimal; never the less, it is important for all of us to revisit the safe guards and steps that we as residents and property owners need to take to be prepared for the wild fire season. Remember to clear under growth around and near your structures to have a good clear defensible space around it. Additionally, have a "go kit" ready in the case of a mandated evacuation in the event of a wildfire near you. There is good information and recommendations located on the NRFPD website (www.colorado.gov/pacific/northrouttfire) under the Wildland Fire Safety tab.

BURN PERMITS

Through a joint effort of the Fire District, Routt County Environmental Health, and the State Air Pollution Control Division, we continue to follow the Routt County Open Burn Plan and can issue you a permit at **no cost!** In an effort to make all pile burning safer, piles will be burned with snow on the ground only. Due to fire danger concerns, we will no longer be burning piles throughout the summer and fall months. Once the snow leaves the ground, we will be available to issue you residential campfire permits. Feel free to give us a call and we can go over all of the details.

EMERGENCY INFORMATION SYSTEM

NOTE: Are you aware that Routt County has a system in place which will notify you of special emergencies in the County? Be sure to sign up for reverse notification on Routt County Alerts web page to receive critical messages to your home telephone, cellular telephone, and email or text in the event you are ever needed to evacuate during wildfires or other disaster situations.
